28 Section 1. The Village Manager is authorized to apply for funds in the approximate
29 amount of \$3,212 and execute such contracts and agreements as are required between Miami-Dade
30 County and the Village of Biscayne Park to provide for an expansion of the services provided by the
31 Records Improvement Project in substantially the form as attached hereto.

33 Section 2: The Village Manager is authorized to do all things necessary to carry out the
34 aims of this Resolution.

36 Section 3: This resolution shall become effective immediately upon its adoption.




