5.a Proposed Code Changes to Chapter 5 (draft dated January 21, 2015)

Summary of items brought up at the Community & Board Workshop held on

5.b January 15th requiring **further consideration and consensus amongst Joint Board members:**

- ◆ 5.3.4 (d): Consideration to allow mailboxes placed at the street line.
- ◆ 5.3.4 (f): Suggestion that 80% of street frontage has a 5' clear zone.
- ◆ 5.3.4 (f) (v): Further discuss the requirement for a permit to plant a tree in the swale.
- ◆ 5.3.4 (f) (vi): Consideration of definition for 'organic mulch'.
- ◆ 5.3.4 (g): Consider removal of 'visitor and temporary service vehicle parking' requirements.
- ◆ 5.3.4 (l): Consideration of using a caliper size for the trees that would be the responsibility of the Village.

- ♦ 5.3.4 (I): Consideration of adding language that Village responsibility would be dependant on available budgetary funds.

Proposed language:

Property owners shall be responsible for the removal of dead and diseased trees, with the exception of trees that have been certified as dead and diseased by a certified arborist and are of a caliber greater than 96 inches which shall be the responsibility of the Village, depending on the availability of budgeted Village funds. If a tree trunk is on both the swale and the adjacent property, the Village shall acquire three (3) quotes and share the cost 50/50 with the adjacent property owner.
