6 **COMMISSION OF THE VILLAGE OF**
7 **BISCAYNE PARK, FLORIDA APPROVING THE**
8 **EXPENDITURE OF POLICE FORFEITURE**
9 **FUNDS OF NOT MORE THAN \$2,968.50 FOR**
10 **THE PURCHASE OF AUTOMATED EXTERNAL**
11 **DEFIBRILLATORS; PROVIDING FOR AN**

16 WHEREAS, Automated External Defibrillators save many lives that would have
17 otherwise been lost simply because time is such a critical issue when it comes to heart related
18 emergencies; and,
19

20 WHEREAS, defibrillators are becoming more and more utilized in schools, public
21 buildings and by police and fire rescue personnel throughout the country; and,
22

23 WHEREAS, the Village of Biscayne Park Police Department responds to numerous
24 medical emergency calls within the first two minutes, quite often being the first responders
25 arriving prior to Miami Dade Fire Rescue; and,

27 WHEREAS, having the defibrillators and trained personnel to properly use them in an
28 emergency situation could potentially save a life; and,

30 WHEREAS, the expenditure of not more than \$2,968.50 for the purchase of two
31 defibrillators from Physio-Control, a Life-Pak Defibrillator distributor under the State of
32 Florida contract, is pursuant to federal and state forfeiture guidelines.

35 **NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COMMISSION**
36 **OF THE VILLAGE OF BISCAYNE PARK, FLORIDA:**

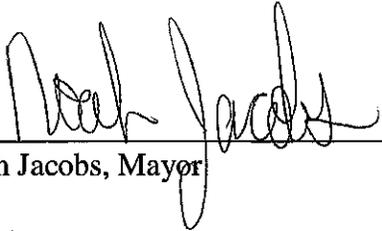
38 **Section 1.** The foregoing "WHEREAS" clauses are true and correct and hereby

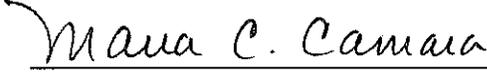

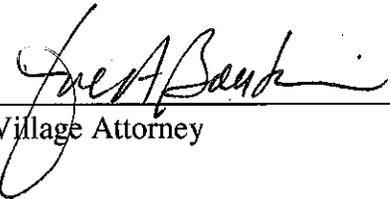
