5 **RESOLUTION OF THE VILLAGE**
6 **COMMISSION OF THE VILLAGE OF**
7 **BISCAYNE PARK RE-APPOINTING DALE**
8 **BLANTON TO THE CODE COMPLIANCE**
9 **BOARD AND THE AD HOC CODE REVIEW**
10 **COMMITTEE; PROVIDING FOR AN**
11 **EFFECTIVE DATE.**

14 WHEREAS the Village of Biscayne Park has established certain statutory and advisory
15 boards and committees, including the Code Compliance Board and the ad hoc Code Review
16 Committee; and

18 WHEREAS the Code Compliance Board, is one of the Village's statutory land use
19 boards, conducting enforcement proceedings, hearings, upon notice and due process, meeting on
20 the second Tuesday of each month, and is required to convene no less than once every two
21 months, pursuant to Florida Statutes and the Village Code; and

23 WHEREAS the Code Review Committee, comprised of the members of the Village's
24 statutory land use boards and five at large members appointed by the Commission, has held
25 public meetings since 2008 to revamp the Village's Land Development Code and is in the
26 process of rolling out recommendations for Commission review and action; and,

28 WHEREAS the Code Compliance Board and the Code Review Committee provide
29 invaluable contributions to the Village, and their members receive no monetary compensation
30 from the Village; and,

32 WHEREAS no alternates currently serve on the Code Compliance Board or on the
33 Code Review Committee; and,

35 WHEREAS resident, DALE BLANTON, has previously served on the Code
36 Compliance Board and on the Code Review Committee and desires to continue to serve the
37 community in these capacities; and,

39 WHEREAS in light of his background of service to the Village, performed with
40 thoughtful deliberation, concern for neighbors, experience and generosity, Mr. BLANTON is
41 very well suited for the task and an excellent candidate for service on the Code Compliance
42 Board and Code Review Committee.

44 NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE
45 VILLAGE OF BISCAYNE PARK, FLORIDA, that
46

47 1. Mr. DALE BLANTON is appointed to serve on the Code Compliance Board
48 initially as an alternate appointee, until such time as a position is vacated by
49 resignation, deemed to be abandoned, or otherwise becomes available, at which time
50 Mr. BLANTON shall serve as a full voting member of the Code Compliance Board
51 until such time that the vacated position receives the elected official's appointee.


52 2. Mr. DALE BLANTON is appointed serve on the Code Review Committee as a




