5 **A RESOLUTION OF THE VILLAGE COMMISSION**
6 **OF THE VILLAGE OF BISCAYNE PARK, FLORIDA;**
7 **AUTHORIZING THE INTERIM VILLAGE**
8 **MANAGER TO EXECUTE THE NOTICE OF SALE**
9 **FOR A MOTOR VEHICLE FOR THE PURCHASE OF**
10 **TWO (2) VEHICLES FROM THE CITY OF MIAMI**
11 **GARDENS TO BE USED BY THE VILLAGE'S**
12 **POLICE DEPARTMENT; AND PROVIDING FOR AN**
13 **EFFECTIVE DATE.**

16 WHEREAS, it is the Village of Biscayne Park Police Department's mission to protect
17 life and property, prevent crime and reduce the fear of crime in the Village, which includes
18 being adequately equipped; and
19

20 WHEREAS, as part of their necessary equipment, the Police Department's fleet must
21 consist of reliable and safe vehicles to allow the officers to conduct their core services; and
22

23 WHEREAS, the Police Department continues to communicate with other police
24 agencies on the availability of vehicles for donation and/or purchase from their fleet; and

26 WHEREAS, the Police Department has identified two (2) vehicles available for
27 purchase from the City of Miami Gardens after careful review of their maintenance logs and
28 personal inspection of the vehicles; and

30 WHEREAS, the Police Department, has negotiated with the City of Miami Gardens to
31 purchase two (2) 2007 Ford Crown Victorias at a purchase price of two thousand dollars
32 (\$2,000) each; and

34 WHEREAS, in August of 2013, a 2005 Chevy Impala from the Biscayne Park Police
35 Department's fleet was totaled and the Village received a claim in the amount of eight
36 thousand one hundred eighty five dollars (\$8,185) which would offset the purchase of the two
37 (2) vehicles from the City of Miami Gardens and associated costs for striping, identifying
38 markers, etc.

40 **NOW THEREFORE IT IS HEREBY RESOLVED BY THE MAYOR AND VILLAGE**
41 **COMMISSION OF THE VILLAGE OF BISCAYNE PARK, FLORIDA:**



44 **Section 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as
45 being true and correct and hereby made a specific part of this Resolution upon adoption hereof.

47 **Section 2.** The Village Commission of the Village of Biscayne Park authorizes the
48 Interim Village Manager to execute the Notice of Sale for a Motor Vehicle for the purchase of
49 two (2) 2007 Ford Crown Victorias from the City of Miami Gardens at a cost of two thousand

1 dollars (\$2,000) for each vehicle; and further authorizes the Interim Village Manager to obtain
2 title to the vehicles and expend such funds as is necessary to make the vehicles part of the
3 Village Police Department's fleet (striping, identifying markers, etc). The two (2) Notice of
4 Sale of a Motor Vehicle are attached and incorporated by reference into this resolution as
5 exhibits 1 and 2.

7 **Section 3.** This Resolution shall become effective upon adoption.






