24 WHEREAS, the Biscayne Park Foundation has scheduled four major events for the
25 2015 calendar year which will include the sale of beer and wine; and,

27 WHEREAS, the Village Commission of the Village of Biscayne Park approves the
28 events and the sale of beer and wine at these four events by the Biscayne Park Foundation
29 with the provision that all required licensing and insurance requirements are met.

32 NOW THEREFORE BE IT RESOLVED BY THE VILLAGE COMMISSION OF
33 THE VILLAGE OF BISCAYNE PARK, FLORIDA:




