

**RESOLUTION #2007-8**

**A RESOLUTION OF THE MAYOR AND VILLAGE COMMISSION OF THE VILLAGE OF BISCAYNE PARK, FLORIDA ESTABLISHING THE COST FOR ADDITIONAL/UNSCHEDULED TRASH REMOVAL; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, Chapter 6 of the Village Code of Ordinances entitled "Public Facilities and Services," provides that the Village shall determine the full cost for solid waste management and that it shall update that cost annually according to the rule established by the Florida Department of Environmental Regulation; and

WHEREAS, prior to the adoption of Ordinance 2007-8, which amended Chapter 6 of the Code to include regulations concerning additional/unscheduled trash removal, the Code did not address same; and

WHEREAS, the Village Commission authorized an amendment to Chapter 6 of the Code of Ordinances and subsequently adopted Ordinance 2007-8 to provide regulations for additional/unscheduled trash removal; and

WHEREAS, Ordinance 2007-8 provides that the cost for additional/unscheduled trash removal shall be determined annually by Resolution of the Village Commission; and

WHEREAS, the Village Commission of the Village of Biscayne Park desires to establish the cost for additional/unscheduled trash removal;

**NOW THEREFORE IT IS HEREBY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE VILLAGE OF BISCAYNE PARK, FLORIDA, AS FOLLOWS:**

**Section 1.** The foregoing "WHEREAS" clauses are hereby ratified as true and correct and incorporated herein by this reference.

**Section 2.** The Village Commission of the Village of Biscayne Park hereby determines that the cost for additional/unscheduled trash removal shall be set as follows:


(1) **Special Trash Removal Requested by Resident** shall be invoiced at a rate of \$20.00 per cubic yard. White goods and furniture shall be invoiced at \$25.00 each.

(2) **Unscheduled Special Trash Removal in Violation of the Village Code** shall be invoiced at a rate of \$20.00 per cubic yard. Additionally, violators shall be subject to the fines and penalties as established in Section 6.3.9 of the Village Code.


(3) **Exceptional Special Trash Removal (trash which exceeds 40 cubic yards)** shall be removed by an outside contractor approved by the Village, and invoiced for the actual cost of the trash removal and any fees associated with the dumping of same.

**Section 3.** This Resolution shall take effect immediately upon its adoption.


