**RESOLUTION NO. 2018-31**

**A RESOLUTION OF THE MAYOR AND VILLAGE COMMISSION OF THE VILLAGE OF BISCAYNE PARK, FLORIDA, APPROVING A CONSULTING SERVICES AGREEMENT BETWEEN THE VILLAGE OF BISCAYNE PARK AND THE FLORIDA INTERNATIONAL UNIVERSITY BOARD OF TRUSTEES (FIU) TO PROVIDE CULTURAL AWARENESS, SENSITIVITY AND LEADERSHIP TRAINING PROGRAM TO THE VILLAGE OF BISCAYNE PARK POLICE DEPARTMENT; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE THE AGREEMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE VILLAGE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Florida International University Board of Trustees (“FIU”) Communication Arts Department’s Cultural Diversity & Leadership Trainings has been established by the FIU Communication Arts Department faculty to offer training programs tailored to police departments to develop skills of cultural awareness, sensitivity and leadership for the communities they serve; and

**WHEREAS**, the Village of Biscayne Park (“Village”) desires to provide such training to its Police Department Officers; and

**WHEREAS**, the Mayor and Village Commission find that entering into the Consulting Services Agreement with FIU is in the best interest of the Village of Biscayne Park Police Department and its residents (“Agreement”).

**NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COMMISSION OF BISCAYNE PARK, FLORIDA THAT:**

**Section 1.** The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and hereby made a specific part of this Resolution upon adoption hereof.

**Section 2.** The Village Commission of the Village of Biscayne Park hereby approves the Agreement between the Village and FIU for the provision of cultural awareness, sensitivity and leadership training to the Village Police Department, a copy of which is attached as Exhibit “1,” together with such non-material changes as may be acceptable to the Village Manager and approved as to form by the Village Attorney. The Village Manager is authorized to execute the Agreement and expend budgeted funds on behalf of the Village.

**Section 3.** This Resolution shall become effective upon adoption




