**RESOLUTION NO. 2018-33**

**A RESOLUTION OF THE VILLAGE COMMISSION  
OF THE VILLAGE OF BISCAYNE PARK, FLORIDA,  
SETTING FORTH THE CORRECT FISCAL YEAR  
2018-2019 VILLAGE REAL AND PERSONAL  
PROPERTY TAXABLE VALUE, AND PROPOSED TAX  
LEVY; RATIFYING THE ADOPTION OF  
ORDINANCES NO. 2018-05 AND 2018-06,  
ESTABLISHING THE VILLAGE'S 2018-2019  
MILLAGE RATE AND ADOPTING THE FISCAL  
YEAR 2108-2019 BUDGET; AND PROVIDING FOR AN  
EFFECTIVE DATE**

WHEREAS, in accordance with Section 200.065, *Fla. Stat.* the Village of Biscayne Park (“Village”) properly held two Public Hearings to set the fiscal year 2018-2019 millage rate and adopt the fiscal year 2018-2019 budget; and

WHEREAS, the Florida Department of Revenue subsequently determined and notified the Village that its statutorily required Budget Summary and Notice of Proposed Tax Increase advertisements were incorrect, because the Village’s proposed tax value of real and personal property and corresponding property tax levy were understated, respectively (a copy of the TRIM Certification letter from the Florida Department of Revenue is attached hereto as Exhibit “A”), and

WHEREAS, Section 200.065(13) allows the Village to correct these statutory deficiencies by re-advertising the correct Budget Summary and Notice of Proposed Tax Increase advertisements and re-holding the hearing at which the Village’s proposed taxable value of real and personal property and corresponding tax levy are announced, *Fla. Stat.*; and

WHEREAS, the Village has re-advertised the corrected statutorily required Budget Summary and Notice of Proposed Tax Increase, along with a new hearing date, location and time (a copy of the corrected advertisement is attached hereto as Exhibit “B”)

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COMMISSION OF THE VILLAGE OF BISCAYNE PARK, FLORIDA THAT:**


**Section 1.** The foregoing “WHEREAS” clauses are true and correct and hereby ratified and confirmed by the Village Commission.

**Section 2.** As required by Section 200.65, *Fla. Stat.*, the Village hereby announces the proposed Village taxable value of real and personal property for fiscal year 2018-2019 is \$217,723,560.00; and further announces the corresponding proposed tax levy for fiscal year 2018-2019 is \$2,111,919. Furthermore, the Village ratifies the adoption of Ordinances 2018-05 and 2018-06 setting the Village millage rate for fiscal year 2018-2019 at 9.70 mils per each \$1,000 of assessed value, which is 11.63 percent greater than the rolled-back rate of 8.6898 mils; and adopting the Village’s fiscal year 2018-2019 Budget.

**Section 3.** This Resolution shall become effective upon adoption.


