- **PUBLIC WORKS:**

The Public Works Team removed the seasonal banners from the bridge. The replacement banners have been ordered; we are awaiting their arrival. Mowed and weeded all of the medians throughout the Village. Mowed all Village owned lots and the alleyways. Repaired one of the lawnmowers that was giving us some issues.

Repaired the broken step for the shed at the Rec. Center. Watered the New Butterfly Park and Log Cabin landscaping, the landscape adjacent to the Log Cabin and Village Hall landscaping and the Community Signs. Planted more Mohly Grass along the bridge. Two Australian Pines have been removed from the median located at NE 118th Street & 7th Ave. Removed and trimmed the Coconut Palms at the Rec. Center. Repaired the fence for the Tot Lot at the Rec. Center.

Manager continues to work with the Village Attorney and FEMA regarding debris reimbursement. Attended Public Safety Advisory Board meeting. Attended Miami Dade City & County Management Association luncheon. Assisted staff and residents as needed.
