- **PARKS & RECREATION:**

The Parks and Recreation Manager worked on Winter Fest preparations and set up. Manager assisted in Election Training. Staff continued seasonal recreation center decorations. Manager received confirmation of successfully passing the Certified Playground and Safety Inspection Course and Exam. Weekly grounds and building maintenance.

- **PUBLIC WORKS:**

The Public Works Team mowed the Rec Center and the Ball Field, Butterfly Garden at NE 109 St and Village Lot at 110th and 10th Ave. Repaired pot holes throughout the Village as needed (9) locations. Coordinated with Rec Manager to help with the Christmas decorations. Watered newly planted plants and trees at Village Hall.

Road Signs were added at NE at 109th St. for 10 mph. Repaired broken sprinkler heads as needed on NE 6th Ave median. Set up room for the Charter Review Committee meeting. Assisted with the placement of barricades on Griffing at the Railroad Tracks / 107th Street due to malfunctioning system to divert traffic as needed. Worked with TECO Gas on repair of a gas line leak at 450 NE 121 St.

ADMINISTRATION:

Manager continues to work with the Village Attorney and FEMA regarding debris reimbursement. Attended Charter Review Advisory Board and Biscayne Park Foundation meetings. Assisted staff and residents as needed.
