- **PUBLIC WORKS:**

- Removed Weeds along NE 6th Ave
- Removed seeds from Alexander Palms along NE 6th Ave
- Watered the Pentas along NE 6th Ave
- Removed newly installed speed humps to reevaluate the configuration
- Trimmed Oak Tree at 115th Street & 8th Court that was growing into the adjacent property
- Trimmed Royal Poinciana at 121st Street & 11th Place that was blocking the Stop Sign
- Scuffed the clay at the Rec. Center
- Mowed and weed-eat the Ballfield at the Rec. Center
- Assisted the Recreation Manager with the removal of a low hanging tree limb
- Removed a tree limb that was blocking the right of way at 113th Street & 10th Ave
- Started to remove shooters from the base of trees where that are starting to grow into the right of way

- **ADMINISTRATION:**

Manager continues to work with the Village Attorney and FEMA regarding debris reimbursement. Met with auditor regarding items for 2019 audit. Attended Public Safety Advisory Board. Worked on agenda for Oct. 1 Commission meeting. Assisted residents as needed.
