**RESOLUTION NO. 2012-18**

**AN RESOLUTION OF THE VILLAGE COMMISSION OF  
THE VILLAGE OF BISCAYNE PARK, FLORIDA,  
ESTABLISHING THE ANNUAL WASTE FEE ASSESSMENT  
FOR THE VILLAGE OF BISCAYNE PARK, FLORIDA FOR  
THE FISCAL YEAR BEGINNING OCTOBER 1, 2012;  
PROVIDING FOR SEVERABILITY; PROVIDING FOR  
INCLUSION; AND PROVIDING FOR AN EFFECTIVE  
DATE.**

WHEREAS, the Village of Biscayne Park utilizes Miami-Dade County Office of the Property Appraiser, Administrative Division, (hereinafter referred to as "the County") to collect the Village's annual waste fee assessment on the TRIM Notices and Tax Bills; and,

WHEREAS, the County requires that the Village submit its rate by June 1, 2012; and,

WHEREAS, since 2009-10 the assessment rate was maintained even though the Village faced one of the largest revenue losses in its history due to a drastic decline in property taxes; and,

WHEREAS, the goal of this administration was to not only maintain the existing rate, but to continue providing top level services to the residents of the Village Biscayne Park, and,

WHEREAS, the Public Works Department, the Finance Department and the Village Manager's office have met several times and have completed a thorough assessment of the Sanitation budget and the necessary enhanced services to be provided to the residents of the Village of Biscayne Park as they relate to sanitation and waste management; and,

WHEREAS, the Public Works Department has determined certain necessary improvements in personnel scheduling and equipment in order to provide waste services to the community; and,

WHEREAS, for the fiscal year beginning October 1, 2012, the total proposed solid waste management fee assessment for the entire Village is estimated to be \$725,400; and,

WHEREAS, the assessed properties are hereby found to be specially benefitted by the provision of solid waste collection services, and solid waste management fee assessment is estimated to be \$558 per residential unit; and,

**NOW THEREFORE IT IS HEREBY RESOLVED BY THE MAYOR AND  
VILLAGE COMMISSION OF THE VILLAGE OF BISCAYNE PARK, FLORIDA:**

**Section 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and hereby made a specific part of this Resolution upon adoption hereof.


1           **Section 2.**     The Finance Director is authorized to submit to Miami-Dade County, by  
2 June 01, 2012, the Village of Biscayne Park annual waste fee assessment of \$558.00 per  
3 residential unit. The Finance Director is to also provide the County with the data file containing  
4 folio numbers with district information, which will be placed on the TRIM Notices and Tax Bills  
5 of the Village's residents.

7           **Section 3.**     Prior to October 1, 2012, the Mayor and Village Council shall update  
8 Section 17-4, of the Village's Code of Ordinances entitled "Imposition of Solid Waste  
9 Management Fee Assessment", to update the annual solid waste management fee to the fees  
10 identified herein.

12           **Section 4.**     This Resolution shall become effective upon adoption.


