








WHEREAS, the Department and the Contractor heretofore on this 23<sup>th</sup> day of August 2011 entered into an Agreement whereby the Department retained the Contractor to perform Maintenance of all Landscape and/or turfed areas within the Department's Right of Way, having the limits described on Exhibit "B" of the original contract.

WHEREAS, said Agreement has a renewal option which provides for a renewal if mutually agreed to by both parties and subject to the same terms and conditions of the original Agreement;

NOW, THEREFORE, this Agreement witnesseth that for and in consideration of the mutual benefits to flow each to the other, the parties agree to a renewal of said original Agreement for a period beginning the 14<sup>th</sup> day of October, 2012 and ending the 13<sup>th</sup> day of October, 2013  
at a cost of \$ 3,980.01 to be paid to the Village by FDOT.

All terms and conditions of said original Agreement shall remain in force and effect for this renewal.
