6 A RESOLUTION OF THE VILLAGE COMMISSION  
7 OF THE VILLAGE OF BISCAYNE PARK, FLORIDA,  
8 SUPPORTING THE EFFORTS TO PLAN AND SEEK  
9 FUNDING FOR THE RESTORATION OF THE LOG  
10 CABIN AND BUILDING OF A NEW VILLAGE HALL  
11 AND POLICE MUNICIPAL SITE; PROVIDING FOR  
12 AN EFFECTIVE DATE

16 WHEREAS our historic log cabin, built in 1933, currently houses our Village Hall  
17 municipal administrative offices and a portion of our police department; and,  
18

19 WHEREAS, the log cabin is in a serious state of disrepair and deterioration, both  
20 inside and out; and,  
21

22 WHEREAS, due to the lack of adequate space in the log cabin, we expend  
23 approximately \$13,000 a year in the rental of outside storage spaces, and rental of a mobile  
24 modular unit for the police administrative offices; and,  
25

26 WHEREAS, due to inadequate insulation and aged infrastructure, we expend  
27 increased utility costs and we do not provide proper ADA compliance; and,  
28

29 WHEREAS, budget allocations have been made in the 2011-12 annual budget for  
30 our planners, Bell David, and for our government relations team, the Caserta Group, to plan  
31 a strategy and to seek any and all available funding.

35 **NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COMMISSION**  
36 **OF THE VILLAGE OF BISCAYNE PARK, FLORIDA, THAT:**

40 **Section 1.** The foregoing "WHEREAS" clauses are true and correct and hereby  
41 ratified and confirmed by the Village Commission.

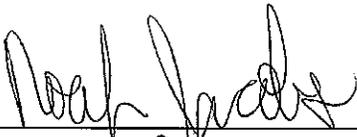
43 **Section 2.** The Village Commission supports and joins the efforts of our

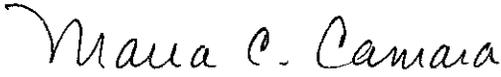
