5 **A RESOLUTION OF THE VILLAGE**
6 **COMMISSION OF THE VILLAGE OF**
7 **BISCAYNE PARK, FLORIDA;**
8 **DESIGNATING THE VOTING DESIGNEE**
9 **FOR THE MIAMI DADE COUNTY**
10 **LEAGUE OF CITIES TO REPRESENT THE**
11 **VILLAGE OF BISCAYNE PARK IN 2015;**
12 **PROVIDING FOR AN EFFECTIVE DATE**

15 WHEREAS, the Miami Dade County League of Cities (“MDCLC”) was established in
16 1953 to advocate for local governance and to support municipalities in Miami Dade County,
17 and MDCLC is a valuable resource for municipal elected officials and administration; and

19 WHEREAS, the Village of Biscayne Park (“Village”) is a member municipality of the
20 MDCLC; and,

22 WHEREAS it is appropriate for each member municipality to designate one official as
23 the voting representative, and one alternate, for purposes of the election of MDCLC leadership,
24 adoption of resolutions undertaken during business meetings and to generally represent the
25 municipal member before the MDCLC; and

27 WHEREAS, the MDCLC will hold its 61st Annual Installation Ceremony in February,
28 2015, when designated voting representatives are installed in such capacity on behalf of the
29 member municipalities.

32 NOW, THEREFORE, BE IS RESOLVED BY THE VILLAGE COMMISSION OF
33 THE VILLAGE OF BISCAYNE PARK, FLORIDA:

36 **Section 1:** That the above recitals are true and correct and are incorporated herein by
37 this reference.


39 **Section 2:** That Mayor David Coviello is appointed as the Village’s voting


