5 **A RESOLUTION OF THE VILLAGE COMMISSION**
6 **OF THE VILLAGE OF BISCAYNE PARK, FLORIDA;**
7 **APPROVING DEBRIS REMOVAL SERVICES**
8 **CONTRACT WITH GRUBBS EMERGENCY**
9 **SERVICES, LLC; AND PROVIDING FOR AN**
10 **EFFECTIVE DATE.**

12 **WHEREAS**, in July 2018, the Village issued RFP 2018-04 for “Debris Removal and
13 Disposal Services (“RFP 2018-04”);

14
15 **WHEREAS**, on July 23, 2018, the Village advertised RFP 2018-04 in the Daily
16 Business Review;

17
18 **WHEREAS**, the Village also advertised RFP 2018-04 on the Village website;

19
20 **WHEREAS**, the Village received responses to RFP 2018-04 from the following three
21 companies: Custom Tree Care Disaster Response, DRC Emergency Services, and Grubbs
22 Emergency Services;

24 **WHEREAS**, in August 2018, the Village staff reviewed the three bid submissions and
25 determined that Grubbs Emergency Services, LLC (“Grubbs”) presented the most responsible,
26 responsive, and cost effective proposal to provide the services; and

28 **WHEREAS**, on September 11, 2018, the Village Commission approved the staff’s
29 rankings of the proposals and adopted Resolution 2018-24, authorizing the Village Manager
30 and the Village Attorney to negotiate an agreement for Debris Removal and Disposal Services
31 with Grubbs Emergency Services, LLC for debris removal and disposal services.




